Description

Province-wide spatial data demonstrating lands in the province that have been withdrawn from the mining claim registry, lands that have certain conditions tied to acquisition of mining claims, or relevant information pertaining to restrictions may apply. There are two types of alienations: withdrawals and notices. An alienation is represented by one polygon*. Polygons may overlap and gaps within and between polygons are allowed.
